# 1. TYPES OF AFFILIATE

- 1.1. Two types of affiliate exists as per ECC Constitution: Full Affiliate and Associate Member
- 1.2. Full Affiliate is generally cycling clubs and receives full affiliation and the applicable benefits.
- 1.3. Associate Member can be a cycling club / academy or an individual person but only receives limited benefits.

## 2. CONDITIONS OF AFFILIATION

- 2.1. Application and Renewal of affiliation must be done in writing to East Cape Cycling on the prescribed form included at the end of this document.
- 2.2. Renewal of affiliation must be done by 31 January each year. Failing to renew by this date will automatically terminate affiliation.
- 2.3. Affiliation period will be valid for 1 calendar year i.e. 1 January to 31 December.
- 2.4. A full years affiliation fees are applicable, irrespective of the time of year when the application is made. No pro-rata rates are applicable.
- 2.5. If an affiliate disaffiliates during the year the affiliation fee will not be refunded in full or on a pro-rata basis.

- 2.6. Affiliation fees will not be waivered under any circumstances.
- 2.7. If an Associate Member wants to upgrade to a Full Affiliate it must be done a minimum of 3 months before the ECC AGM.
- 2.8. Upgrading from Associate Member to Full Affiliate will require the full Full Affiliate fee to be paid on upgrade.
- 2.9. On successful application for affiliation, the affiliate will abide and comply with the East Cape Cycling Constitution in respect to interaction and compliance to provincial matters.
- 2.10. East Cape Cycling can request the new affiliate Club name to be changed when initial application is made in the case where there may be a conflict with other affiliate names.
